Edwards Place is believed to be the first neighborhood of its kind in the nation in offering new hope to people with disabilities and their parents. Through this project, our aim is keeping families together by providing affordable housing to parents and their children.

There was a time when children with developmental disabilities didn't outlive their parents, but advances in medicine and more active lifestyles have extended their life expectancy. These children, now adults, outlive their caregivers and parents often reach an age at which they can't care for their adult children and both may be forced into assisted living, separating the family.

But we know that many families want to stay close even as they age.

Edwards Place is aimed at preventing this separation. Coming on the heels of the recently completed Aloha Community Center, Edwards Place will provide a vital piece in the life-span plan that Edwards Center founders envisioned over forty years ago. Not every family has the same needs, so each of the new homes will have some special considerations. All will be wheelchair accessible on the first level with floors that are all level with no thresholds. There will be damage-resistant countertops, well-built cabinets, touch faucets, and special showers and toilets. But most importantly there will be a community of support from Edwards Center. Daily activities will be available at the Community Center, Nancy's Café will be open for coffee, and caregivers can be available on an "as needed" basis.

When completed, Edwards Place will uniquely position Edwards Center as the only agency in Oregon providing a variety of living options across the entire life-span.

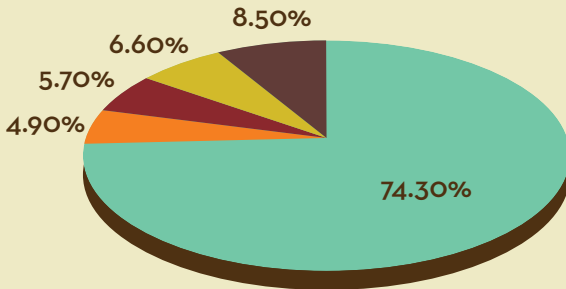

## 2012 -2013 FINANCIAL REPORT

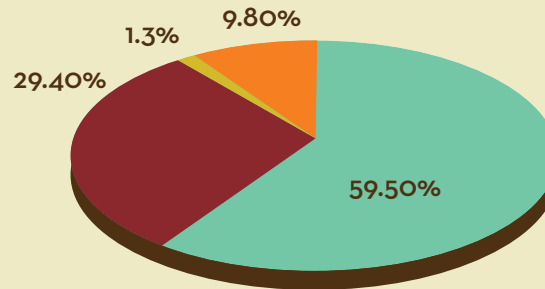
